PRESIDENT'S PERSPECTIVE

Accessibility to dental care for elderly and frail people, specificity of health services, proportionality





We must be forward thinking and acknowledge the urgency of this topic. We cannot wait until we have an oral health crisis but need to act today, when we can make a difference to patients' health, by supporting prevention and providing appropriate and timely treatment.

European Parliament- "Integrated Care – Don't forget about the mouth", 29 November 2017



Oral diseases are a major public health problem in Europe. They have considerable negative impacts on the general health and quality of life of populations, especially the elderly and frail people. Poor oral health is linked to difficulties to speak, eat, drink, swallow and take medicines. Malnutrition and severe health conditions like pneumonia can be associated with poor oral health. As the life expectancy of populations is expected to increase, this burden will continue to grow. In addition, oral health inequalities are an important challenge in the EU, with an excessive oral health burden on some frail groups of population.

There is an urgent need to improve oral healthcare for older and frail people.

Healthcare and social care services, public authorities and the oral health professions should work together to develop appropriate strategies. The initiatives should include specific training in oral health for those who have regular contact with older and frail people. Integrated care is part of the solution. This is the message the Council of European Dentists delivered during the event organised at the European Parliament "Integrated"

Care – Don't forget about the mouth", 29 November 2017.

With a still growing and ageing population it is the responsibility of the national authorities to ensure sufficient resources to meet this challenge. In addition, the high quality of educational curricula should reflect the needs of the ageing population. A minimum duration and specific evolving competences in training of dental practitioners can secure the optimal quality of care. It is the role of the Council of European Dentists to promote it.

As they are very often the first contact point with a healthcare system for EU citizens, dentists like doctors and community pharmacists are key actors in the European healthcare systems in Europe. The regulation of their professions serves a public interest in terms of safeguarding the quality and availability of healthcare services and it protects public health. In a single market, setting the rules for assessing the proportionality of regulations concerning healthcare professions should remain a key competence of Member State to guarantee patient safety, high quality healthcare and safe and accessible services.

CODE OF ETHICS



In May 2017, the CED adopted the revised Code of Ethics that takes into account national codes and the new EU rules on data protection. First adopted in 1965 and regularly amended, the CED Code of Ethics contains agreed guiding principles for professional conduct and ethics of dentists, which underpin high quality of dental care throughout Europe. It covers the commitment to the patient and the public, the practice of the profession and electronic commerce.

CED POSITION ON THE DIRECTIVE FOR A PROPORTIONALITY TEST BEFORE THE ADOPTION OF NEW REGULATION FOR PROFESSIONS

While regulation of health professionals is based on the need to protect essential public interest, the planned introduction of an obligatory proportionality test would greatly limit the margin of discretion and scope for national authorities.

The CED asked for health professions to be excluded from the scope of the planned Directive on a proportionality test for regulation professions to bring it into line with the approach to health enshrined in the EU Treaties, relevant EU legislation and EU case law.




