Θέμα: Κατάθεση προτάσεων για την αποδοτικότερη λειτουργία των Ομάδων Εργασίας

του CED από Β. Σταθόπουλο

Πρόεδρο & μέλη του ΔΣ/Επ. Δ. Σχ,

Την Πέμπτη 21.11.2024, παραμονή της Γενικής Συνέλευσης του CED, οι συντονιστές των Ομάδων Εργασίας είχαν προσκληθεί στο τελευταίο τμήμα του ΔΣ του CED προκειμένου να παρουσιάσουν (α) την πρόοδο των ργασιών των ομάδων τους και (β) να υποβάλουν προτάσεις για την αποδοτικότερη λειτουργία των ΟΕ. Στο πλαίσιο της συζήτησης αυτής κατέθεσα προφορικώς και γραπτώς τις ακόλουθες σκέψεις-προτάσεις.

«Mr. President and Members of the CED Board,

I am truly honored to be invited to address you and share my proposal concerning the effectiveness of the Working Groups (WGs), as well as some additional thoughts I believe could help enhance our operations. I propose that the WGs be structured more robustly to improve their efficiency. Please allow me to outline a few key suggestions:

- The maximum number of participants per WG should be limited to 20 members.
- Each Association may have one active member and one substitute member. If there are more than two members from any one Association, that Association will be asked to approve the selection of the two primary members. This may require a tentative adjustment to the Bylaws in the future.
- Every three years, each member should be re-appointed by their respective Association.
- If a member misses two-thirds or more of the meetings, their membership should be reinstated by their Association.
- Board members, while ex-officio, will still be included in the participant count for each Association.
- The President and liaison members of the Board will be exempt from the above participant limitations.
- Each WG member should participate in at least one project during their three-year term.
- All official communication via email should be managed by the WG Secretary, with the exception of internal procedural discussions. Social or informal communications within the WG should remain internal.
- CC emails should be strictly handled by the office.

These proposals are presented for your consideration and will be implemented at the discretion of the Board. Thank you for your attention to these matters.»
